



GOLD PROCEDURES

Process overview

Seller verification

Kakol Real Estate requires information about the seller of the gold i.e. Company name, owner name, website, documents, contracts.

Contract

Kakol Real Estate provides draft SPA or contract from the buyers for the seller's acceptance. Contracts are available only to verified sellers.

Transaction

Gold doré bars or bullion must be delivered to refinery. Gold is always smelted and payment is processed upon Final Assay Report.

- 3. Offer from the seller
- 4. Information about buyer
- 5. Meeting: buyer seller
- 6. Onboarding KYC/AML (Zurich only)
- 7. SPA/Contract
- 8. Execution of transaction




Zurich EF

- 1. Seller is given Loomis account number
- 2. Sellers delivers gold to Loomis Zurich
- 3. Gold is transported to LBMA refinery
- 4. Gold is smelted
- 5. Final Assay Report is produced
- 6. Seller issues Invoice
- 7. Payment is made in 24 to 72 hours
- 8. Transfer according to contract

Dubai

- 1. Seller is given refinery name and address
- 2. Sellers delivers gold to refinery
- Gold is smelted
- 4. Final Assay Report is produced
- 5. Seller issues Invoice
- 6. Payment is made according to contract
- 7. Payment options:
 - cash (instant)
 - cryptocurrency (on request)
 - transfer (up to 72 hours)



Documentation

- 1. Full CIS
- 2. Working number
- 3. Email
- 4. Person Passport
- 5. Person in Passport should be a signatory of the seller's company
- 6. Trading License
- 7. Incorporation License
